Continue to utilize the US mail or the online alternative (www.hindscountyms.com) for current tag renewals by visiting www.hindscountyms.com. *DO NOT MAIL CASH*. Tags paid for with a check will be held for 10 business days.

Property payments, registration renewals, and completed, signed disabled placard applications can be mailed to: P.O. Box 1727, Jackson, MS 39215. Be sure to include license plate number, parcel number and phone number where you can be reached when mailing in information.

Partial property payments, new tag registrations and tags outside of the grace period cannot be processed online.

2023 tax notices have been mailed. Everyone will receive a property tax notice. If your taxes are paid through an escrow account, the statement is for informational purposes only.

Homestead Exemption can be filed in the Tax Assessor's office January 1- April 1. Contact the Tax Assessor for any questions regarding homestead or other exemptions at 601-968-6626.

Current year taxes (2023) can be paid in installments contact our office at 601-968-6608 for more information.

Online tag renewal:

The vendor charges a non-refundable convenience fee to process payments. There is a **\$2.25** convenience fee when using a debit card **in the office**. A **2.25%** convenience fee for all in office or online credit card transactions. There is a \$75,000 limit when using online services: www.hindscountyms.com

Forms of Payment

We accept cash, money orders, checks, debit and credit cards. Do not mail cash. Decals/plates paid for with a check will be mailed after 10 business days. You have 30 days to register your vehicle after moving into the state . If not registered within 30 days a \$250 fee will be added to the cost of registration.

HB 2187-revises the eligibility requirement for veterans to be issued certain license plates for DAV. Any service connected disabled veteran (not only permanent & total), rated as <u>70% or higher</u> (includes 75% & 100%) by the Veterans' Administration is privileged to purchase two (2) motor vehicle license plates and one motorcycle tag in his or her county of legal residence, for one dollar (\$1.00). The law stipulates that any Veteran not permanent and total disabled will be required to submit an updated letter each year to show their rating has not been reduced. Effective July 1, 2023.

SB 2841- To provide that an owner of a private carrier of passengers or motorcycle may choose a regular license tag with a black background and a white pinstripe border, with "MISSISSIPPI" printed at the top and the name of the county printed at the bottom; to prescribe an additional fee of \$38.25 for the issuance of such tag; to provide for the distribution of the additional fee collected from the issuance of such license tag; Beginning January 1, 2024

PERSONALIZED BLACK OUT tags are available now for an additional \$53 added to registration annually. Proceeds go to fallen firefighters and law enforcement fund.

Penalty fees for late registration/ renewal:

You have 7 business days after purchasing a vehicle in state to register the vehicle. On the 8th business day there is a **5%** penalty. If you purchase a vehicle out of state, you have 7 working days plus 48 hours to register the vehicle.

The penalty for late tag renewal is 5% after the first 15 days the tag is due. There is an additional penalty of 5% for each additional 30 days the tag remains overdue. The maximum penalty is 25%. Once you reach the 25% penalty you will not be allowed any Legislative

Egg Roll In A Bowl



Ingredients: 1 lb ground turkey or beef, sesame oil, 1 garlic clove,minced, sliced scallions, sliced mushrooms of choice, coleslaw mix, ground ginger, coconut aminos or low sodium soy sauce.

Cook ground turkey or beef, in 1/2 tbsp sesame oil, over medium heat. Remove form pan and set aside. Brown garlic in 1/2 tbsp sesame oil for about 1 minute on medium heat. Add scallions, mushrooms, coleslaw mix and ground ginger and cook 4 minutes on medium heat. Add cooled ground turkey back into the pan and cook to desired tenderness. Pour in coconut aminos or soy sauce. Serve as is or over white or brown rice. Optional: top with fresh green onions or scallions, sesame seeds and Sriracha sauce.
